Belimo Expands Warehousing and Distribution Operations Across the Americas to Meet Growing Market Demand

Belimo, a global leader in damper actuators, control valves, sensors, and meters continues to expand its warehousing, logistics, and customization operations across the Americas to support strong customer demand and long-term growth. These investments reflect Belimo's commitment to ensuring fast delivery times, and operational excellence as global trends drive increased demand for energy-efficient building technologies and healthier indoor air.

Following another year of strong growth across the Americas region, Belimo has significantly expanded its logistics footprint in both the eastern and western United States. Additional details on Belimo's sales performance will be shared with the release of its sales revenue results on January 19, 2026.

In Connecticut, Belimo recently signed a multi-year lease for a new 170,000-square-foot warehousing facility in Stratford, designed to support anticipated growth in the coming years. The Stratford facility will become operational in Quarter 2, 2026. Once the Stratford facility is open, Belimo's total operations related space in Connecticut will total 282,000 square feet.

"The new space in Stratford provides an immediate solution to our current capacity needs while giving us flexibility as we plan for future growth in the region," said Tom Pelillo, Vice President of Logistics and Customizing, Americas. "It strengthens our ability to maintain high product availability and meet customer expectations as demand continues to rise."

Complementing this East Coast expansion, Belimo is also expanding its Sparks, Nevada facility, which supports logistics, customization, and distribution operations for the western United States.

The Sparks location has expanded to 85,000 square feet, significantly increasing capacity and enabling faster, more responsive service for customers across the region.

These Americas investments are driven by rising global demand for sustainable, high-performance building solutions. Climate change and rapid urbanization are accelerating the need for energy-efficient building solutions and healthier indoor air—areas where Belimo technologies play a critical role.

The recent expansions in Connecticut and Nevada are part of Belimo's broader global growth strategy, which also includes recent facility expansions in Hinwil, Switzerland; Shanghai, China; and Grossröhrsdorf, Germany. Together, these investments ensure Belimo is well positioned to support customers worldwide while continuing to scale operations responsibly.

By expanding warehousing, logistics, and customization capabilities, Belimo reinforces its long-term commitment to delivering reliable solutions, operational resilience, and exceptional customer value in a rapidly evolving global market.

The Belimo Group is the global market leader in the development, production, and sales of field devices for the energy-efficient control of heating, ventilation and air conditioning systems. The focus of our core business is on damper actuators, control valves, sensors and meters. In 2024, the Company reported sales of CHF 944 million and currently employs over 2,800 people.
