

## Confirmation of Compliance with Belimo List of Hazardous Substances (LHS)/ EU RoHS Directive/ EU REACH Regulation

Dear Belimo Supplier,

Belimo strives to avoid the use of materials that place an unnecessary strain on the environment and are difficult to discard. It is our goal to avoid the use of critical substances which pose a risk to the environment and to people's health and safety.

We ask you to sign this document and by this to confirm that all products (preparation, article and component) you are selling to Belimo are compliant with Belimo List of Hazardous Substances (LHS), EU RoHS and EU REACH.

- Clause 1: The LHS is governed by clause 15 of Belimo's Supply Agreement. It is the Supplier's responsibility to always comply with the currently valid version of the LHS published on Belimo's website. You are obliged to inform Belimo immediately about a deviation from the requirements given in the LHS. Please use the provided Belimo template for the reporting.
- 2. Clause 2: Belimo products must always comply with the requirements of the most recent edition of the EU Directives 2011/65/EU (RoHS 2) and (EU) 2015/863 (RoHS 3), which limit the use of certain hazardous substances in electric and electronic products including their mechanical parts. You are obliged to inform Belimo immediately on the presence of a substance (name and CAS no.) if it exceeds in certain applications the standard threshold of 0.1% w/w (0.01% for Cd). In such a case, Belimo also needs to know if any component (homogenous material), which is part of the product supplied to Belimo makes use of an annex III or IV exemption of the EU RoHS. Please use the provided Belimo template for the reporting.
- 3. Clause 3: Belimo products must always comply with the requirements of the most recent edition of the EU Regulation (EC) No 1907/2006 (REACH). This covers the substances on the candidate list (SVHC) as well as substances listed in the annexes XIV (authorization list) and XVII (restriction list). You are obliged to inform Belimo immediately whether any SVHC constitutes greater than 0.1% w/w of any component which is part of the product supplied to Belimo (REACH article 33). Please use the provided Belimo template for the reporting.

## Clause 1: Compliance with LHS
